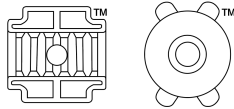

1.3: Design Requirements

*Specifier Notes: The **GenieClip** acoustic assembly is a proprietary product used for fastening gypsum wallboard to a supporting structure, while simultaneously isolating it from vibration. This significantly reduces the amount of impact and airborne sound filtering from rooms above, below, and alongside.*

*To maximize the noise control capacity and potential of the **GenieClip**, a professional acoustical engineer should be consulted.*

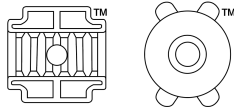
*To maximize the acoustical performance of the **GenieClip**, it is recommended the dead or shear load not exceed 36 pounds per **GenieClip**.*

1.3.1: Dead or Shear Load: Maximum design load of 36 pounds per each **GenieClip**.

1.3.2: Conform to UL Fire Resistance Directory design assemblies, where required.

1.4: Submittals

1.4.1: General: Submit listed submittals in accordance with Conditions of the Contract and Division 1 Submittal Procedures Section.



1.4.2: Product Data: Submit product data, including manufacturer's guide specifications product sheet, for specified products.

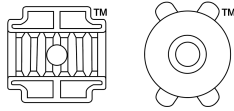
1.5.1.2: Manufacturers' Qualifications: Manufacturer capable of approving application method.

1.5.2: Regulatory Requirements: [specify applicable requirements of regulatory agencies].

1.5.3: Mock-Ups: Install at project site a job mock-up using acceptable products and manufacturer-approved installation methods. Comply with workmanship standard. Comply with Division 1 Quality Control (Mock-Up Requirements) Section.

1.5.3.1: Mock-Up Size: As determined by acoustical consultant.

1.5.3.2: Maintenance: Maintain mock-up during construction for workmanship comparison; remove and legally dispose of mock-up when no longer required.



1.5.3.3: Incorporation: Mock-up may be incorporated into final construction upon Owner's approval.

1.5.4: Pre-installation Meetings: Conduct pre-installation meeting to verify project requirements, substrate conditions, manufacturer's instructions, and manufacturer's warranty requirements. Comply with Division 1 Project Management and Coordination (Project Meetings) Section.

1.5.5: Pre-installation Testing: Conduct pre-installation testing as follows: [specify substrate testing; consult with flooring manufacturer].

1.6: Delivery, Storage, and Handling

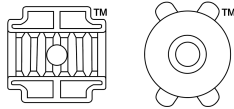

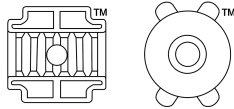

2.5: Mechanical Fasteners

2.5.2.1.1: Minimum Pullout and Shear: 108 pounds

2.5.2.2: To Steel Framing Members (Less than 20 Gauge): Screws 1-1/2 inches (38 mm) minimum length; #8 minimum shank; Type S (fine thread); bugle-, wafer-, or hex-head screws of equal or greater size.

2.5.2.2.1: Minimum Pullout and Shear: 108 pounds

2.5.2.3: To Steel Framing Members (20 Gauge through 12 Gauge): Screws 1-1/2 inches (38 mm) minimum length; #8 minimum shank; Type S (fine thread); self-drilling tip; bugle-, wafer-, or hex-head screws of equal or greater size.

2.5.2.3.1: Minimum Pullout and Shear: 108 pounds

2.5.2.4: To Concrete: Anchors 1-3/4 inches (44 mm) minimum length, 3/16-inch to 1/4-inch diameter. Mushroom head or screw-in type anchor in accordance with fastener manufacturer's instructions. Powers Fasteners or approved equal.

2.5.2.4.1: Minimum Pullout and Shear: 108 pounds

2.5.2.5: To Concrete Masonry Units: Anchors 2-1/4 inches (57 mm) minimum length, 1/4-inch diameter. Designed for use in concrete masonry units in accordance with fastener manufacturer's instructions. Powers Fasteners or approved equal.

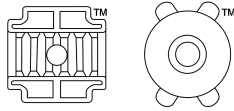

3.2.1: Site Verification of Conditions: Verify substrate conditions, which have been previously installed under other sections, are acceptable for product installation in accordance with manufacturer's instructions.

3.3: Installation – General

3.3.1: Install **GenieClip**, sealant, and drywall furring channels in accordance with manufacturer's instructions.

3.3.2: Mechanically fasten **GenieClip** to structure with screws, bolts, or anchors, dependent upon structure.

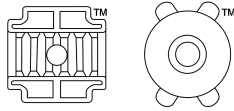

3.3.3.1: Install as specified in UL Fire Resistance Directory, where required.

3.3.4: Space **GenieClip** at maximum of 24 inches (600 mm) by 48 inches (1,200 mm) on center for walls and ceilings.

3.3.5: Do not exceed design load (pull and shear) of 36 pounds per **GenieClip**.

3.3.6: Stagger **GenieClip** installation, so dead load is supported by all support members.

3.3.7: Splicing Drywall Furring Channels:

3.3.7.1: Splice drywall furring channels with minimum of 6-inch (150-mm) laps.

3.3.7.2: Secure laps with 2 framing screws or 18 gauge tie wire double wrapped.

3.3.7.3: Locate splices between **GenieClip**.

3.3.7.4: Do not locate splices on **GenieClip**.

3.3.8: Install **GenieClip** on 1 side of wall assembly, unless otherwise indicated on the drawings.

3.3.9: Flanking Noise

3.3.9.1: Review installation details to prevent structure-borne flanking noise.

3.3.9.2: Do not allow drywall furring channels or gypsum board to contact foreign materials, including floors, ceilings, or wall framing members.

3.3.10: Ensure rubber isolator of **GenieClip** is in firm contact with structural member.

3.3.11: Gypsum Board:

3.3.11.1: Install gypsum board in vertical or horizontal position with 1/8-inch (3-mm) to 1/4-inch (6-mm) gap around perimeter for acoustical sealant application.

3.3.11.2: Install gypsum board in accordance with ASTM C840 as specified in Section 09250

3.3.12: Acoustical Sealant

3.3.12.1: Seal potential air leaks with acoustical sealant to achieve best Field Sound Transmission Class (FSTC).

3.3.12.2: Seal electrical outlets and penetrations with acoustical sealant.

3.3.12.3: Apply fire-rated acoustical sealant at locations where fire-rated assembly is required.

3.3.13: Putty Pad Sealant:

3.3.13.1: Acoustically seal with putty pads, electrical boxes in walls and ceilings in which **GenieClips** are used

3.4: Installation – Walls

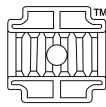

3.4.2: Space drywall channels maximum of 24 inches (600mm) on center.

3.4.3: Locate first drywall furring channel parallel to floor and maximum of 3 inches (75mm) above floor and 1 drywall furring channel maximum of 6 inches (150 mm) from ceiling.

3.5: Installation – Ceilings

*Specifier Notes: Special consideration should be given to all penetrations, such as recessed light fixtures, electrical boxes, exhaust fans, and sprinkler heads to ensure the control of both STC and IIC noise transfer. Consult **Pliteq Inc.** for additional information.*

3.5.1: Install drywall furring channels perpendicular, parallel, or angular to framing members.

3.5.2: Space Drywall Furring Channels:

3.5.2.1: Maximum of 24 inches (600 mm) on center with:

3.5.2.1.1: Single layer of 5/8-inch (16-mm) gypsum board

3.5.2.1.2: Double layer of 5/8-inch (16-mm) gypsum board, weighing less than 2.25 pounds per square foot per layer

3.5.2.1.3: Single layer of 1/2-inch (12-mm) high-strength gypsum board

3.5.2.1.4: Double layer of 1/2-inch (12-mm) high-strength gypsum board

3.5.2.2: Maximum of 16 inches (400 mm) on center with:

3.5.2.2.1: Single layer of 5/8-inch (16-mm) gypsum board

3.5.2.2.2: Double layer of 5/8-inch (16-mm) gypsum board

3.5.2.2.3: Single layer of 1/2-inch (12-mm) regular-strength gypsum board

3.5.2.2.4: Double layer of 1/2-inch (12-mm) regular-strength gypsum board

3.5.3: Locate **GenieClip** maximum of 6 inches (150 mm) from ends of drywall furring channels.

3.5.4: Locate drywall furring channels maximum of 3 inches (75 mm) from parallel wall assemblies.

3.6: Field Quality Requirements:

3.6.1: Manufacturer's Field Services: Upon Owner's request, provide manufacturer's field service consisting of product use recommendations in accordance with manufacturer's instructions.

3.6.2: Field Tests should be performed by an independent acoustical laboratory accredited by the U.S. Department of Commerce, National Institute of Standards and Technology under the National Voluntary Laboratory Accreditation Program for the specified test procedure.

3.6.3: The cost for all field acoustical testing, corrective work associated with the installation of the resilient sound isolation clips, walls, and ceilings to meet the minimum requirements, shall be borne by the flooring contractor(s).

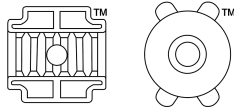
